Kriteria dalam Evaluasi dan Kualifikasi

Kriteria Evaluasi dan Kualifikasi

❑ Keuangan:

- Rata-rata omzet tahunan (*Average Annual Turn Over*) → 0,5x (estimasi nilai kontrak per lot/ waktu kontrak) untuk 3 tahun terakhir.

❑ Pengalaman:

- Mempunyai pengalaman penyediaan alkes sejenis dengan jumlah minimum tertentu sebagaimana dicantumkan dalam **Dokumen Pemilihan** (*bidding document*), pada satu tahun tertentu dalam periode 7 tahun terakhir.
- **Apabila peserta tender adalah pabrikan (Original Equipment Manufacturer - OEM)**, maka ditambahkan persyaratan:
 - ✓ Mempunyai pengalaman memproduksi alkes sejenis sekurang-kurangnya 4 tahun terakhir
 - ✓ Rata-rata produksi tahunan untuk alkes sejenis dalam 4 tahun terakhir minimal 50% dari total jumlah/kebutuhan yang disebutkan dalam setiap lot/kontrak
- **Apabila vendor bukan OEM**, harus mendapatkan **Otorisasi** dari Pabrik (*Manufacturer's authorization*) dengan format sesuai pada dokumen pemilihan.

Persyaratan *Joint Ventures* | Pajak

Persyaratan *KSO/Joint Venture*

- Meskipun tidak wajib, pembentukan **KSO** diperbolehkan, dengan maksimum 3 anggota.
- Surat Kuasa** akan ditandatangani oleh pemimpin perusahaan dari masing-masing anggota KSO.
- KSO **tidak perlu** didaftarkan sebagai entitas baru di Indonesia atau di tempat lain, bukti KSO sudah cukup.
- Semua anggota JV secara bersama-sama/ seluruhnya bertanggung jawab atas pelaksanaan seluruh kontrak.

Catatan: Joint Venture adalah pilihan untuk mengatasi kebutuhan yang tidak mencukupi oleh satu perusahaan

Sistem Pembobotan dalam Evaluasi Tender

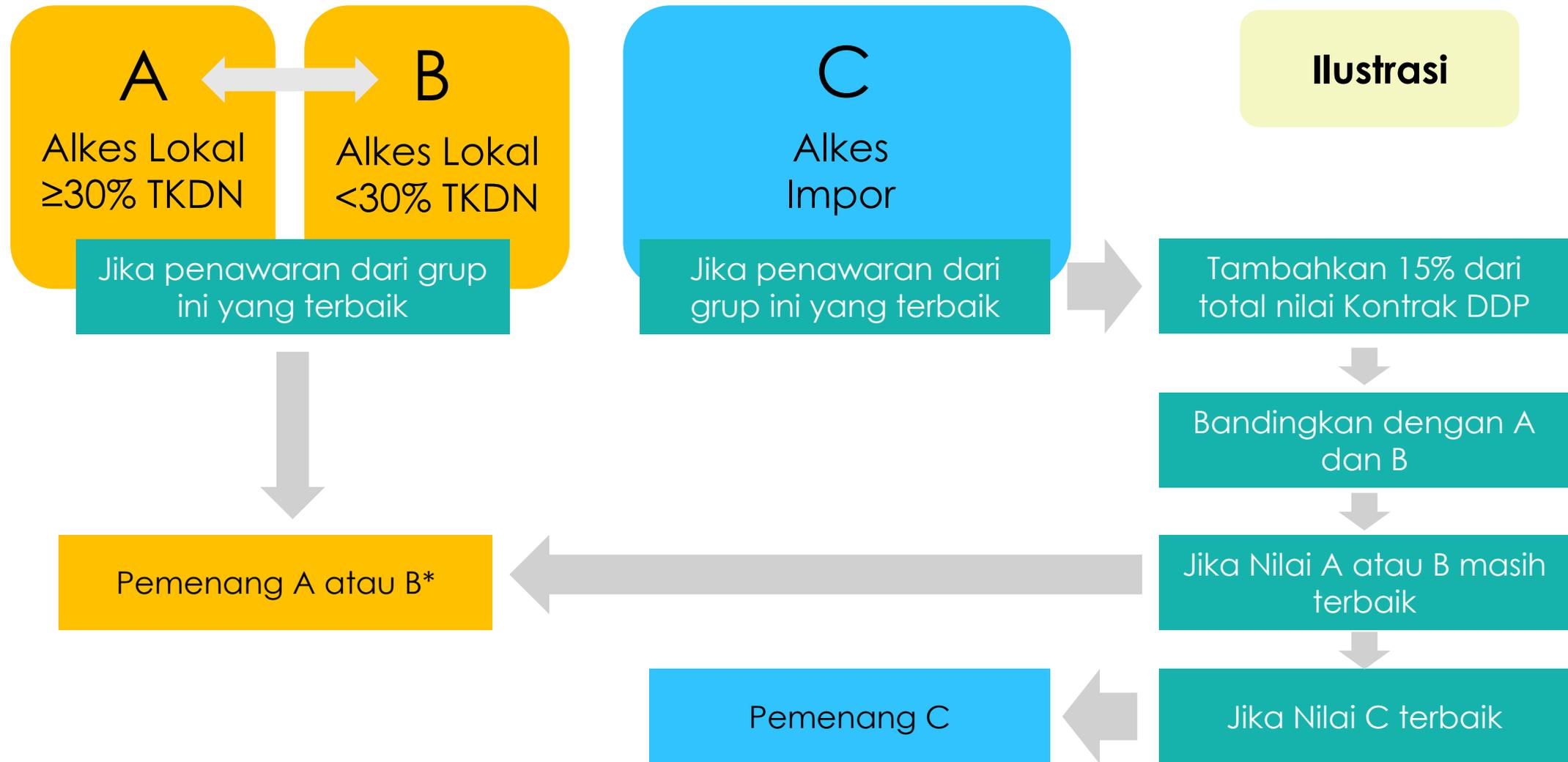
☐ Metoda Penilaian

- Terdapat dua metode Evaluasi yang diterapkan:
 - Sistem Nilai dengan pembobotan (**weighting system**) pada proses evaluasi **penilaian teknis (spesifikasi teknis)** dan **penilaian finansial (harga)** untuk setiap lot (kontrak).
 - Sistem Harga Terendah, penawaran dievaluasi berdasarkan harga terendah yang memenuhi semua persyaratan teknis setelah koreksi aritmatik untuk setiap lot (kontrak).
- Dalam Sistem Nilai, evaluasi teknis menggunakan **Kriteria wajib (Mandatory)** dan **Kriteria Teknis yang diberikan Nilai (Rated Criteria)** untuk evaluasi penilaian teknis:
 - Ketentuan pemenuhan **Mandatory technical specifications** untuk menjamin kebutuhan spesifikasi teknis alkes minimal dan menjaga kualitas alkes
 - Ketentuan **Rated Criteria** adalah pemenuhan terhadap spesifikasi teknis alkes diatas yang diwajibkan, yang akan mendapat nilai /skor teknis
 - Rasio Pembobotan **untuk Technical dan Financial** akan bervariasi berdasarkan jenis alkes dan hasil **Analisa pasar**.

Margin of Domestic Preference / Preferensi Harga

- ❑ *Margin of domestic preference (Preferensi Harga)* dapat diberikan dalam evaluasi harga dengan hal-hal sebagai berikut:
 - ✓ Barang yang diproduksi di Indonesia (**Kelompok A dan Kelompok B**), dibandingkan dengan barang yang diproduksi di Luar Negeri (**Kelompok C**);
 - ✓ Jika sebagai hasil dari perbandingan, suatu penawaran dari **Kelompok A** atau **Kelompok B** merupakan penawaran paling menguntungkan, maka penawaran tersebut yang akan dipilih;
 - ✓ Jika berdasarkan perbandingan sebelumnya, penawaran dari **Kelompok C** paling menguntungkan, maka pada harga barang yang dievaluasi akan ditambahkan sebesar 15% dari harga penawaran **DDP (tidak termasuk inland transport, asuransi dan pajak)** masing-masing barang yang akan ditawarkan. Apabila dari hasil perbandingan lebih lanjut penawaran **Kelompok A** atau **Kelompok B** adalah yang paling menguntungkan, maka penawaran tersebut akan dipilih. Jika tidak, maka akan dipilih penawaran yang paling menguntungkan dari **Kelompok C**.

- Selain pdf, bidder juga harus melampirkan file excel teknis dan finansial
- Pastikan dokumen dapat dibuka dan tidak terkunci
- Pisahkan file bagian Teknis dengan bagian Finansial

AATO

- Bidder menyampaikan AATO berupa *financial report* dari Bidder maupun Anggota JV **bukan** *financial report* konsolidasi/milik parent company atau afiliasi

Tidak boleh *Alternative Bid*

- Bidder hanya menawarkan barang yang sesuai dengan spek, tidak dapat memberikan opsi barang A atau B

Bid Check List

- Bidder memberikan list dokumen yang disampaikan dalam penawaran
- Bidder memberikan Summary/ringkasan pada tiap dokumen kualifikasi
